



RENTAL APPLICANT CHECKLIST:

- We require rental applicant(s) to produce a combined annual salary of 40-50x the monthly rent of the apartment; if these requirements are not met, a *guarantor* is needed.

(The requirements below may vary depending on the Landlord)

- 1) Most recent pay stub(s)
- 2) Copy of Photo ID
- 3) Most recent bank statements: checking/savings (Must have your name printed on the statement!)
- 4) Brokerage account statements (if available)
- 5) First 2 pages of past two years of tax returns
- 6) Employment letter and company letterhead stating salary and length of employment
*If self-employed a letter from your accountant stating annual income and source of income

GUARANTOR REQUIREMENT CHECKLIST:

- We require the guarantor to produce an annual income of approximately 80-90x the monthly rent of the apartment.
- 1) Fill out separate application as if securing apartment for yourself
(additional application fee will most likely be required)
 - 2) Copy of bank statement for any checking or savings account listed
(Must have your name printed on the statement!)
 - 3) Copy of Photo ID
 - 4) Brokerage account statement(s)
 - 5) Last two pay stubs
 - 6) First 2 pages of past two years of tax returns
 - 7) Employment letter on company letterhead stating salary and length of employment
*If self-employed a letter from your accountant stating annual income and source of income
